**Brake control installations are \$199.95 plus tow plug and taxes.** Hitch installs on a case by case basis.

**\* Required - "weight distribution system" is required for trucks under 1 Ton without dual wheels.** Rental cost \$ 25.00

Ask for written quote for periods of over 2 weeks

Cancellation fee of \$100.00

Previous rental customers qualify for a discount of 10% on next rental scheduled within 12 months

We can deliver or pick up a rental trailer for \$3.50 per mile one way from Decatur plus set up cost of \$49.00

**RESERVATION DEPOSIT** \$100.00 due at time of scheduling and is "Non refundable"

**OFF SEASON RENTAL RATE**- 10% off rate, December 10<sup>th</sup> thru Mar 15<sup>th</sup>

**Late return charges** - Per day \$ 150.00

**DAMAGE & CLEANING.** Deposit of \$300.00 (\$500 Toy-box units) will be refunded no earlier than 2 business days after return inspection. **Unit must be, clean in & out, absolutely no smoke smell, holding tanks dumped, LP filled & no damage in or out.**

(Prior inspection by Sullivan RV required and all claims settled before release of deposit escrowed funds.)

Tire failure while on a trip is the responsibility of the renter. Replacement tires must be new and same size.

Pick up before noon constitutes a rental day; drop off later than 9am constitutes a rented day.

Orientation requires min 40 minutes time, and will be done no later than 1 pm Monday - Friday.

**Do not put awnings and pop-ups away wet, and absolutely no smoke smell or the Deposit is forfeited**

All returns must be during Sullivan RV business Hours (a walk-around inspection with management is suggested. All damage decisions made by the Sullivan inspections are final, and not up for negeotion. You must make any disputes of damage assessments at drop off time, make time for the return inspection, it could take a little time), and pickups can only be scheduled Monday thru Friday 9am to 2pm We do require full coverage insurance to include our rented vehicle. **If your insurance company will not extend full coverage to our rental vehicle, we do require the purchase of Damage Waiver Coverage for the rental period.**
